International Business Review is the official journal of the European International Business Academy (EIBA), and the EIBA Board has scheduled an IBR Paper Development Workshop (IBR-PDW) as part of the pre-conference programme of the 43rd EIBA Annual Conference (EIBA 2017) taking place in Milan, Italy, 14-16 December 2017.

The purpose of the IBR-PDW is to provide junior scholars with developmental feedback on their current research projects in international business studies. While we hope that many of these papers will be eventually submitted to *IBR*, the purpose of the PDW is broader: to improve the quality of IB research and bring new scholars into the IB field. We invite original papers from **junior authors or junior faculty members who have not previously published in *International Business Review***. In particular, we hope to attract papers from scholars (1) who are located in universities in emerging economies or in universities that offer limited support for international business research, and/or (2) who are trained in disciplines less commonly associated with the field (e.g., human geography, political science, ethnography, or economic history) but interested in conducting international business research.

The IBR-PDW will begin with an introduction by Pervez Ghauri, the Editor-in-Chief of IBR. The participants will then be divided into two groups, and feedback on each paper will be provided by

two of the following panellists: Pavlos Dimitratos (University of Glasgow, UK), Rian Drogendijk (University of Groningen, Netherlands), Andreja Jaklič (University of Ljubljana, Slovenia), Dorota Piaskowska (University College Dublin, Ireland), Jonas Puck (WU Vienna University of Economics and Business, Austria), Roger Strange (University of Sussex, UK). The panellists will discuss the strengths and weaknesses of each paper, with the aim of providing robust yet constructive feedback to the authors so that they can improve their papers to the standard required for IBR publication. The 2017 IBR-PDW will be held between 08:30 a.m. and 12:30 p.m. on Thursday 14 December at the conference venue (Politecnico di Milano), as part of the pre-conference activities taking place before the formal start of the EIBA 2017 conference that same afternoon. Participants should therefore plan to arrive in Milan the evening before.

Prospective participants in the 2017 IBR-PDW are invited to submit their paper manuscripts to Roger Strange (R.N.Strange@sussex.ac.uk) by Friday **1 September 2017**. Please note that each applicant may make only one submission, but may also have submitted the same (or another) version of the paper for presentation at the EIBA 2017 Conference. All authors should indicate their names, e-mails, and affiliations, on the cover page of the manuscript. Papers must be less than 10,000 words in length, and should follow the *IBR Guide for Authors* (<https://www.elsevier.com/journals/international-business-review/0969-5931/guide-for-authors>).

Participation at the IBR-PDW is limited to 10 papers. Participants will be selected based on the quality of their submitted work, and will be notified about the acceptance of their submissions no later than **29 September**. Participants will be required to confirm their participation by **14 October**, and they will then be invited to submit a revised manuscript (i.e., the version to be discussed at the IBR-PDW) by **24 November**.

NOTE: All participants must be registered for the EIBA 2017 Conference (www.eiba2017.org) before they confirm their attendance at the IBR-PDW.
