### Specialisation (2) Global Business and Institutions

We are looking for candidates in the field of **global business and institutions** that have a specific orientation towards **empirical studies on business, industries and institutions with an emphasis on innovation and globalization issues**. We would privilege profiles that have consistent research and teaching experience in the following subject matters:

- Business and industrial economics
- Economics and management of business enterprises
- High-tech and sustainability-oriented innovation

The successful candidate is expected to carry out research in the field of global business and institutions. The candidate will also have teaching duties at the School of Management. She/he will work closely with the Faculty and PhD students of the Global Business and Institutions research group (GBI, <u>http://www.gbi.polimi.it/gbi/</u>). The mission of the Global Business and Institutions group is to carry out rigorous and innovative interdisciplinary researches mainly on business strategies and economic institutions. Specifically, the GBI group focuses on the following domains:

- Micro-foundations of business strategies and performances
- Business in context: Understanding the role of institutions and the economic environment
- Business for sustainable development

The selected candidate is expected to attend international conferences and present their research results at these events, as well as publishing their findings in the most prestigious international journals. The selected candidate will also participate in activities and/or projects within the School of Management that are relevant to their area of expertise. They may also be required to help in the organisation of conferences and in the coordination of other events on a periodical basis.

### Requirements

The candidate should:

- Hold a PhD in Management Engineering, Economics or Business Studies or closely related disciplines
- Be an internationally recognised scholar in the fields related to innovation and globalization issues
- Have a significant track record in teaching to a high standard, and innovation and development of course curricula, in Business and industrial economics, Economics and management of business enterprises and High-tech and sustainability-oriented innovation programmes at undergraduate, postgraduate and executive levels, and also within business schools and business programs.
- Have a long-term proven ability and experience of teaching in English
- Have an excellent record of research achievement as demonstrated through high-impact publications in international journals (ISI/SCOPUS) relevant for the field of Business, Economics, Management
- Show a clear inclination and ability to promote and take an active part in international research networks and international research partnerships
- Have a strong interest and commitment to funded and practically relevant research
- Show their ability and willingness to work in a culturally and academically diverse School environment, to prioritise inter-disciplinary research, and establish a dialogue within the broad range of disciplines in the Management Engineering field.
- Have an open attitude towards real-world problems with the aim of delivering relevant ideas and recommendations to policymakers, managers and social stakeholders.
